Board has found Mr. Simon guilty of violation of volunteer handbook section 102, paragraph 2, attendance requirements and also volunteer handbook section 102, paragraph 4, attendance and participation. Motion Ash, 2nd Bauer to dismiss Michael Simon from the membership. MC unanimously
